

MINUTES

ANNUAL MEETING of the WEST LOCH FAIRWAYS HOMEOWNERS ASSOCIATION

MINUTES:

There being no corrections, the minutes of the last Annual Meeting held on February 19, 2013 were approved as written.

REPORT OF OFFICER:
