**CALL TO ORDER:** Having determined the presence of a quorum, President Hochstein called the meeting to order at 6:01 p.m.

#### **ORDER OF BUSINESS**

<u>APPROVAL OF MINUTES</u> – President Hochstein moved and Director Ashley seconded the motion to approve the minutes of the Regular Board of Directors' meeting held on December 10, 2012 as written. Directors Hochstein, Ashley, Hiltner, Rogers, Nii and Hanson voted yes; Directors FeBenito and Sparacio abstained. Motion carried.

<u>SITE/COVENANT MANAGER'S REPORT</u> – Site/Covenant Manager Robert Allocco provided a written site management report and violations log to all Board members and Community Association Manager. He reported on the following items: violations, site and light inspections, meetings with homeowners; chicken trapping, tree trimming; water feature and common area lighting and irrigation repairs

The Board authorized the managing agent to send a letter to West Loch Fairways Townhomes inviting their Directors to a meeting at Asing Park to discuss water and irrigation.

payment of the invoice for emergency repairs to the Fort Weaver Road irrigation main line for \$1,351.93. Motion carried with unanimous consent.

Motion: President Hochstein moved and Secretary Rogers seconded the motion to approve the proposal to remove the coconut trees and replace the trees with Foxtail palms (items 1,2,3 &5) for \$3,340). Motion carried with unanimous approval.

Directors Hochstein, Hanson, Hiltner, FeBenito, Nii, Ashley and Sparacio voted yes; Director Rogers voted no. Motion carried.

- D. Status of Water Feature Lighting Repairs Project completed Motion: President Hochstein moved and Vice President Hiltner seconded the motion to approve the additional expense for water feature lighting repairs in the amount of \$1,085. Motion carried with unanimous consent.
