

MINUTES

ANNUAL MEETING of the WEST LOCH FAIRWAYS HOMEOWNERS ASSOCIATION

ROLL CALL: MR. ROBERT HOCHSTEIN, THE CHAIR AND CURRENTLY SERVING AS BOARD PRESIDENT, announced that he had been advised that a quorum was present and called the meeting to order at 7:00 p.m.

PROOF OF NOTICE OF MEETING:

The Chair noted for the record that the Certificate of Mailing dated January 16, 2018 signed by the Managing Agent, as proof of notice of meeting, will be filed with the meeting records.

INTRODUCTIONS:

The Chair, introduced the Directors present at this meeting namely: Directors Mike Nii, Dominic Sparacio and Richard Ashley, Beverly Febenito, Paul Olitsky, Troy Fournier, Joshua Wooldridge. Mailani Barnett, Site Manager. Representing Associa Hawaii were Darnell Barksdale and Thomas Tabacco, Community Association Managers, and Admin Assistants.

CONDUCT OF MEETING:

The Chair announced that in accordance with the Hawaii Revised Statutes Chapter 421J-6, this meeting would be conducted according to the most current edition of Robert's Rules of Order, Newly Revised.

MINUTES:

There being no corrections, the minutes of the last Annual Meeting held on February 21, 2017 were approved as written.

REPORT OF OFFICER:

1. President's Report: PRESIDENT HOCHSTEIN READ HIS REPORT WHICH FOCUSED ON THE FOLLOWING TOPICS: ALLEYWAYS; WEST LOCH FAIRWAYS BIKE PATH; ILLEGAL PARKING; WEBSITE AND TREE REPLACEMENT BY THE CITY

ELECTION OF DIRECTORS:

The Chair announced that according to the Bylaws, the Board of Directors shall be composed of nine persons. There were three vacancies on the Board that had to be filled. Three Directors shall serve for three years.

Michael Nii, Paul Olitsky and Dominic Sporacio agreed to run again and their names were placed on the ballot. There were no nominations from the floor.

ANNOUNCEMENT OF ELECTION RESULTS:

The Chair announced the new Directors that were elected: Directors Michael Nii, Paul Olitsky and Dominic Sporacio. The three Board members will serve for three years.

CONFIRMATION OF QUORUM:

The Chair was provided with the final tally of the ownership represented at this meeting. The final tally was as follows: Total percentage present was 59.0278% consisting of 5.2778% in person and 53.7500% by proxy and 10.1389% for quorum only.

New Business

Resolution on Rollover of Funds: The following resolution was adopted:

“Resolved by the owners of the Association of Apartment Owners of WEST LOCH FAIRWAYS, that the amount by which each member’s assessment in 2018 exceeds the total payments of the Association for maintenance, repairs and other expenses and capital expenditures of the Association as the Board of Directors has appropriately paid or determined payable, shall be applied to 2019 regular member assessments.”

OWNER’S FORUM:

The Chair announced that he would recognize individuals for a maximum of two (2) minutes for each speech and would give preference to those individuals who have not had a chance to speak. Owners asked questions regarding various association matters.

Announcement: The Chair announced that a brief organizational meeting for all Directors would immediately follow this meeting.
