# Message from Councilmember Ron Menor

Aloha Friends and Neighbors,

have continued to work hard in trying to get the City to address the concerns of our community. I have also remained very involved in community activities.

#### **EWA BEACH SKATE PARK**

I have been extremely impressed with the community grassroots effort. led by students from James Campbell High School, to rehabilitate Ewa Beach Skate Park. The park, which had been a safe place for community members to gather, has fallen into a state of disrepair and is in desperate need of maintenance. The number one issue that needs to be resolved is the resurfacing of the current asphalt surface that has deteriorated over time. This has become a major safety hazard for the people who use the skate park and will need to be remedied. I have arranged a site inspection for this Saturday, February 13th at 10 am at the skate park. I have invited a number of people including officials from the Department of Parks and Recreation, State Representative Bob McDermott, Honolulu City Councilmember Kymberly Marcos Pine, and members of the community to join me on this site inspection. I have already informed Mayor Caldwell's Chief of Staff that I plan to include funds in the City budget for the rehabilitation of the park. The Mayor's office has assured me that if I am able to do so, the City administration will commence repairs in July. Thank you to all of the community members who brought this issue to my attention. I hope to see you on Saturday.

#### **TRI-SCHOOL FILM FESTIVAL**

On March 4th at 5:30 pm, I plan to attend Ewa Makai Middle School's Tri-School Film Festival which will feature films created by students from Ewa Makai Middle School, James Campbell High

### **Update on Community Concerns**

The following are a few of the many concerns that Councilmember Menor has been working on:

#### West Loch Elderly Village

Councilmember Menor forwarded to the Mayor's office a Request for Investigation and Service Report (RISR) on behalf of a resident of West Loch Elderly Village on Renton Road. The resident voiced concerns regarding a number of safety hazards and maintenance issues. One notable hazard is exposed electrical wiring around the property, which was caused by the poor installation of a lighting fixture. The pavement fronting one of the community's laundry rooms is uneven, posing a significant risk to the residents. The resident also requested that the City maintain the grass in the vacant land parcels that are adjacent to West Loch Elderly Village as the grass has grown to be several feet high in certain places. Two separate RISRs are currently pending assignment to the appropriate City department. Councilmember Menor will continue to monitor these issues and will provide any necessary updates.

#### Hanakahi Street

Councilmember Menor also forwarded a RISR regarding the intersection of Hanakahi Street and Kuhina Street. The RISR requests that the stop sign line at this intersection be repainted for safety purposes. The work should be completed in the near future. Councilmember Menor will also be meeting with Department of Transportation Services Director Michael Formby tomorrow to push for implementation of traffic calming measures

on Hanakahi Street.

#### Ewa Beach Park

Councilmember Menor recently met with an Ewa Beach resident who raised concerns about unleashed dogs roaming freely around the park and entering private property without the owner's permission. Councilmember Menor has asked the Honolulu Police Department to look into this situation.

#### West Loch Fairways

Councilmember Menor forwarded a RISR on behalf of the West Loch Fairways Covenant Manager regarding sidewalks that needed repairs on Hamana Street and Maka'aloa Street. Repairs on both streets have been completed.

#### **City Budget**

Mayor Caldwell is expected to submit his budget for fiscal year 2016-2017 to the City Council in early March. The Council will review the Mayor's budget, make necessary amendments, and approve a balanced budget by mid-June. If there are any suggestions for a Capital Improvement Project (CIP) or a community project, please contact Councilmember Menor as soon as possible so that the project can be considered for inclusion in the upcoming budget.

#### Bill 83

Bill 83 (2015) received a public hearing today and was approved by the Transportation Committee. This bill, which relates to the inspection of motor vehicles and mopeds, seeks to regulate the annual inspection of mopeds. This is intended to address community concerns regarding the noise created by uninspected mopeds.



Councilmember Menor recently met with State Department of Transportation Deputy Director Ed Sniffen to discuss a number of Ewa concerns. One of the issues discussed was the possible relocation of a historical artesian well marker to a new. more visible location. Councilmember Menor with UH-West Oahu Interim Chancellor Dr. Doris Ching at UH-West Oahu's Commencement Ceremony. The recently graduated class was the largest in school history.
