UPDATE ON COMMUNITY CONCERNS

Hanakahi Street

Chair Menor is pleased to report that four speed humps were installed along Hanakahi Street on Friday, November 3. This project was initiated in response to concerns that were raised regarding the safety of students who are forced to cross Hanakahi Street while walking to and from school. Ewa Neighborhood Board No. 23 considered the proposed project and ultimately passed a resolution in support of the installation of the speed humps.

Miula Street Speed Bump

It was recently brought to Chair Menor's attention the need for a speed bump on Miula Street in the Ewa Villages. A concerned resident noted cars are constantly speeding along Miula Street during the after school rush hour which has created a hazardous situation for the many students who walk to and from Ewa Elementary School.

The request was forwarded to the City Department of Transportation Services which determined that Miula Street did require a speed bump which was installed late last month.

Ewa Public Swimming Pool

At a previous meeting of Ewa Neighborhood No. 23, a James Campbell High School (JCHS) parent gave a presentation on the current state of the athletics facilities at JCHS. During their presentation, the parent noted that, currently, there is no public swimming pool in Ewa or Ewa Beach.

Chair Menor has met with City Parks Director Michele Nekota and has requested that the City Parks Department utilize planning funds that were approved by the City Council to begin the planning phase for a public swimming pool in the Ewa community. Chair Menor will continue to push for this project and

will provide updates in the future.

Illegal Vacation Rentals

During its November 1 Council Meeting, the City Council heard testimony from Oahu residents regarding the issue of illegal vacation rentals. The Council then voted to approve four resolutions urging Mayor Kirk Caldwell's administration to draft bills for the Council's consideration that would increase regulations surrounding vacation rental units. Moreover, the Council has also requested that a bill be drafted that codifies how the City will enforce regulations pertaining to vacation rental units. As the Council cannot make changes to the Land Use Ordinance, any bill or bills proposed by the mayor's administration would then need to be reviewed by the Planning Commission before being heard by the City Council.

Mayor Caldwell's administration has indicated to the Council that a task force is being created to assist the administration in drafting possible legislation to address the problems created by illegal vacation rentals. Chair Menor will provide any necessary updates in the future.

Ewa Villages Irrigation

The City Department of Facility Maintenance (DFM) and the Ewa Villages Owners Association (EVOA) are currently working to draft a Memorandum of Agreement between the City and the EVOA to designate the required R1 Recycled Water Manager.

Chair Menor has strongly urged the City administration to resolve this issue as quickly as possible. In the meantime, DFM has continued to send City water trucks to water the trees on City medians.
