Congratulations to the **Little League World Series (LLWS) champions!** After an undefeated run through the United States bracket, Honolulu shut out Georgia, 3-0, to clinch the U.S. championship. Hawaii would go on to shut out South Korea, capturing the LLWS with a 3-0 victory.

On September 8, Oahu welcomed the team back in style with a celebratory parade that ended at Honolulu Hale. I had the pleasure of offering congratulatory remarks to the team. This marks the third time that a Hawaii team has won the LLWS. Teams from 'Ewa Beach and Waipio were the first two teams from Hawaii to win the LLWS in 2005 and 2008 respectively. UPDATE ON COMMUNITY CONCERNS

'Ewa Beach Canal Clean Up

Councilmember Menor submitted a Request for Investigation and Service Report on behalf of 'Ewa Neighborhood Board No. 23 member Kurt Fevella regarding the canal that runs parallel to Kilaha Street and 'Ewa Beach Community Park. It was brought to Councilmember Menor's attention that a large amount of debris was blocking the mouth of the canal.

The City Department of Facility Maintenance recently notified Councilmember Menor that the clean up efforts at the canal were completed on September 11 as part of storm preparation protocols for Tropical Storm Olivia.

Holomua Elementary Delineators

Councilmember Menor is happy to report that the traffic delineators that need to be installed near the entrance of Holomua Elementary School are scheduled to be delivered in early October. Councilmember Menor will push for the installation shortly thereafter.

Bill 61 (2018)

Bill 61 (2018) passed second reading at the City Council's September 12 meeting. This bill, if passed, will require public notice, input, and engagement whenever the City administration proposes the removal of a marked crosswalk. These requirements will also apply when a crosswalk is anticipated to be removed as part of a street or highway repaving project.

Resolution 18-150

At the City Council's September 12 meeting, the Council adopted Resolution 18-150 which urges the City Department of Customer Services to fill departmental vacancies, provide more driver licensing appointments, and offer State identification services at additional locations. The resolution was adopted in response to an increased demand for driver licensing and State identification services that has increased lines and wait times at all Driver Licensing Centers.
