# Honolulu Mayor issues additional measures to stop COVID-19 spread

Mayor Caldwell issued the closure of private golf courses/clubs, tennis courts/clubs, and similar sports facilities on O'ahu to further promote social distancing. This took effect on Wednesday, April 1 at 4:30 p.m. and will continue through 4:30 p.m. on Thursday, April 30.

# **HOV Lane Open for All to Use**

In accordance with Governor Ige's Stay-at-Home and Work-at-Home orders and considering the decreased volume of traffic, the State Department of Transportation has suspended the use of the zipper lane and has

Gov. David Ige signed a fourth supplementary proclamation that requires all residents and visitors traveling between any of the islands in the State of Hawai'l to self-quarantine for 14 days. All who travel inter-island will be required to fill out and sign an Interisland Declaration Form.

# **Unemployment Assistance**

#### Medical Insurance for Low Income Individuals

Medical coverage is available for eligible low-income Hawaii residents. Hawaii has two medical assistance programs called Hawaii QUEST and Medicaid Fee-For-Service. For more info, call (808) 587-3521.

# Hawaii QUEST:

Hawaii QUEST, commonly known as QUEST, is a program that provides health coverage through health plans for eligible Hawaii residents. It provides medical and mental health services. QUEST is administered by the Department of Human Services, Med-QUEST Division and is financed through the State of Hawaii and the Federal Centers for Medicare and Medicaid Services. #### Hawaii Medicaid Fee-For-Service

For low income eligible individuals age 65 and over, or who are certified as blind or disabled, coverage is provided under Hawaii's Medicaid Fee-For-Service Program where providers are paid directly for covered services. This program provides limited dental care.

#### Homeowners - Protection from Foreclosure

Federally insured mortgage loans contain special protections under the CARES Act protecting homeowner-borrowers from having their mortgages foreclosed upon due to financial hardship. The CARES Act provides 180 days forbearance to qualifying homeowner-borrowers which may be extended for another 180 days at the borrower-homeowner's request. For more info, call (855) 411-2372

#### Renters - Protection from Eviction

For 120 days after enactment of the CARES Act, property owners are prohibited from filing for eviction against or charging any fees for unpaid rent and fees to a tenant in properties with federally guaranteed loans or participating in federal housing programs. Property owners must also issue a notice to tenants to vacate 30 days before an eviction and the notice to vacate cannot be issued during this 120-day period. #### Concerning the increase in domestic violence during "Shelter in place"

# **SNAP (Supplemental Nutrition Assistance Program)**

SNAP provides food and nutritional support to low-income and needy households, is funded through the U.S. Department of Agriculture (USDA), and is administered in Hawaii by the Department of Human Services (DHS) Benefit, Employment & Support Services Division (BESSD). #### **Small Business Paycheck Protection Program**

Provides small businesses with funds to pay up to 8 weeks of payroll costs including benefits. (Other costs may qualify; see program details.) Funds are in the form of loans and will be forgiven if used for specified purposes and if employees are kept on the payroll or rehired quickly. All small businesses with less than 500 employees are eligible. Non-profits, independent contractors, and sole proprietors are included. Small businesses and sole proprietorships may now apply. Independent contractors and self-employed individuals may apply beginning April 10, 2020.

Apply to Federally Insured Depository Institutions, Federally Insured Credit Unions, and Farm Credit System Institutions. Contact your local lender or bank to see if they are participating.
