### Call to Order

<u>Approval of Minutes</u> – Treasurer FeBenito moved and President Hochstein seconded the motion to approve the September 18, 2023 Regular Board Meeting Minutes as written. Motion carried with unanimous approval.

<u>Site Covenant Manager's Report</u> – The Site Covenant Manager submitted a monthly report, covenant enforcement spreadsheet and fine assessments to the Board and managing agent which will be kept on file at Managing Agent's Office.

- A. <u>Design Review</u> In September 2023, 20 were submitted, 19 were approved, and 1 was disapproved.
- B. Website Previous minutes and the updated DCCRs were posted to the website.
- C. <u>Landscape Committee</u> No updates at this time.
- D. Special Committee for DCC&Rs Revisions No updates at this time.

### **Unfinished Business**

- A. <u>Status of Pump Room Door Replacement</u> This item was not a Pump Room Door Replacement but a repair. RJP Landscaping to send a revised invoice.
- B. <u>Guard Shack Roof Replacement</u> Confirmation was provided by SCM Barnett that the approved proposal from PCI Roofing for \$6451.30 without the optional maintenance would include all materials for the proposed price.
- C. <u>Chicken Removal</u> President Hochstein motioned to approve Mid-Pac Pest Control's proposal of an on-site technician for \$680.63 weekly and \$25 per chicken removal at an amount of up to \$2500 total. Vice President Stewart seconded the motion. The motion carried unanimously.
- D. <u>Alternate Water Sources (Water Feature)</u> This item was deferred until next meeting. Vendor Remigio Piano will meet with members of the board and SCM Barnett.

- E. <u>Irrigation: Lateral Leak Aawa Drive Adjacent to Guard Shack</u> Director Ashley motioned to approve the proposal from RJP Landscaping at the cost of \$2497.90. President Hochstein seconded the motion. The motion carried unanimously.
- F. <u>Light Pole Anchor Replacement and Poles</u> This item is combined with Item G.
- G. <u>Light Pole Replacements</u> President Hochstein moved to approve up to \$2500 for travel and accommodation for a representative from Progressive Electric to inspect a possible pole replacement vendor, Brandon Industries. Vice President Stewart seconded the motion. The motion carried unanimously.
- H. Lot 244 Roots Growing In Toilet This item was moved to executive session.
- I. <u>Motor For Golf Course Water Pump</u> Director Darlow provided an update that this item is considered closed and the association will not be providing a motor for the golf course water pump.
- J. <u>2024 Budget</u> President Hochstein moved to approve the 2024 Operating and Reserve Budget with a maintenance fee increase of 4%. Director Ashley seconded the motion. The motion carried unanimously.
- K. <u>Fiber Optic Camera Work</u> This item was deferred pending additional and newer options available.
